Members Dues-2025

- ✓ Members Dues remain at \$130/New officials dues are \$35
 - ❑ New this season: no assignor fees billed to officials at the end of the year (~\$100/official savings)
 - ❑ As in most recent seasons, Officials will receive pay for any scrimmages (\$124 for varsity; \$99.80 JV; \$87.70 Mod)

 - ❑ Payment options:
 - ✓ Check (payable to “GVLOA”; give/mail to Tom D’Ambrosia)
 - ✓ Cash (see Tom D’Ambrosia-Treasurer)
 - ✓ Paypal
 - ✓ Venmo



Fingerprints - First and Second Year Officials

- New officials must apply for mandatory fingerprints; cost is ~\$102 (one time)
- Section V offers a reimbursement program:
 - Available upon completion of your **second season**
 - 50% of cost (\$51)
 - *New officials from 2024 season-we will apply for your reimbursement upon payment of 2025 dues.*



Eligibility Requirements

- **Pay your dues to Tommy D'Ambrosia**
 - New Officials - \$35
 - Returning Members - \$130
- **Pass the Rules Test via USA Lacrosse**
 - 90% needed to get the certificate...
- **Attend at least 3 of 5 scheduled Pre-Season Meetings**
 - **Pre-Sectional Meeting is required to be a CBO on a sectional game**

Coaches Certification

The pregame equipment certification by the head coach shall act as the team warning. The head coach shall certify to the referee before the game that all players:

- Have been informed what equipment is mandatory and what constitutes illegal equipment.
- Have been provided the equipment mandated by rule.
- Have been instructed to wear and how to wear mandatory equipment during the game.
- Have been instructed to notify the coaching staff when equipment becomes illegal through play during the game.
- Have had their crosses, uniforms and all other equipment inspected by the head coach for meeting specifications.
